The Senior Analyst Institutional Research and Effectiveness is a key leadership role responsible for ensuring that the institution meets the highest standards of educational accreditation, regulatory compliance, and quality assurance. This position is essential in advancing the institution's commitment to Anishinaabe aadziwin (worldview) and fostering continuous improvement to support Shingwauk Kinoomage Gamig's (SKG) mission and growth as a culturally based Indigenous institute.

Key Responsibilities

- Serve as the primary liaison with accrediting bodies, including IAESC, WINHEC, NIAB and other
 professional accrediting bodies to ensure full compliance with institutional and programmatic
 accreditation standards.
- Lead the preparation and submission of accreditation documentation, including new program proposals, program major modification proposals, self-studies, reports, and assessments.
- Coordinate institutional reviews and new program accreditation processes, fostering strategic and sustainable growth.
- Monitor and ensure adherence to all higher education regulations, including those specific to Indigenous institutes and accrediting bodies.
- Develop and implement policies and procedures that align with evolving regulatory requirements and support cultural priorities.
- Analyze institutional data including data from course evaluations, program reviews, and institutional assessments to inform continuous improvement efforts.
- Analyze how well the institution is tracking to realize its strategic goals and objectives
- Provide data analysis to inform institutional governance and decision making
- Develop, revise, and enforce policies related to accreditation, compliance, and academic integrity in alignment with Anishinaabe aadziwin.
- Maintain accurate and comprehensive records of all accreditation and compliance activities.
- Compile and analyze data to produce detailed reports for internal and external stakeholders, including Indigenous communities.
- Act as a key advisor to senior leadership on accreditation, compliance, and quality assurance matters.
- Engage in governance activities, such as Academic Council Board participation, to guide institutional decision-making.
- Foster a culture of quality, compliance, and respect for Anishinaabe aadziwin across the institution, inspiring teams to achieve excellence.
